This notice is provided to you by National Benefit Life Insurance Company "NBL":

NBL's products are life, health and annuity insurance.

<p><b>Data Security</b> We protect your personal information ("data") from unauthorized access and use. To do this, we take security measures that comply with the law. We use computer safeguards and secured files and buildings. We share your data only with those who agree to abide by our security standards. We train our employees how to handle your data.</p> <p><b>Data We Collect and May Disclose</b> Examples:</p> <ul style="list-style-type: none"> <li>• <b>Data you put on applications or other forms:</b> your name, address, Social Security number, beneficiaries, etc.;</li> <li>• <b>Data about your transactions with us or others:</b> your policy coverage, premiums, account balances and payment history, etc.;</li> <li>• <b>Data from consumer reporting agencies</b> and insurance support organizations ("ISOs") that may retain and disclose it to others: your medical history, credit history, etc.;</li> <li>• <b>Data from others:</b> contact information, etc.</li> </ul> <p>We collect this data to process the product you want. Generally, we share it to service your product and as permitted by law.</p> <p>Types of permitted sharing:</p> <ul style="list-style-type: none"> <li>• with your consent or as you direct;</li> <li>• for others to perform services on our behalf;</li> <li>• to comply with legal requirements (such as subpoenas), etc. and</li> <li>• to affiliates, including Primerica, Inc. and other companies owned by Primerica, Inc. (but not to market products to you)</li> </ul> <p>We do not share medical data unless permitted by law.</p>	<p><b>Parties With Whom We May Share Your Data:</b></p> <ul style="list-style-type: none"> <li>• Financial companies: engaged in securities, insurance, debt solutions, etc.;</li> <li>• Non-financial companies: ISOs and companies that service products you request, etc.; and</li> <li>• Others as permitted by law: regulators, law enforcement, etc.</li> </ul> <p>We apply these same policies when you are no longer our client.</p> <p><b>Your Insurance Policy: Correcting Your Data</b> When you apply for insurance, we collect data from ISOs. They may retain and share your data with others.</p> <p>We may disclose without your prior consent all the data we collect:</p> <ul style="list-style-type: none"> <li>• To agents, affiliates, servicers, ISOs and government:             <ul style="list-style-type: none"> <li>-to process and service your requests;</li> <li>-to detect and prevent fraud; and</li> <li>-to report fraud.</li> </ul> </li> </ul> <p>You have the right to:</p> <ul style="list-style-type: none"> <li>• see and copy your data; and</li> <li>• ask us to correct, amend or delete what you think is wrong.</li> </ul> <p>To request or correct your file, write to NBL at 30-30 47th Avenue, Suite 625 Long Island City, NY 11101-3433.
